Office: Trainer **Richard Davis** violated AGCO Rule 7.07(i) stable error necessitating a scratch which carries a monetary penalty of \$300 for a first offence. Ruling **#3328392**.

Apprentice Jockey **Austin Adams**, and Jockey **Da-Sean Gaskin** both excused from their mounts. Replacements were announced on track and put on the television changes scroll.

Jockey's Claim Of Foul #5 Where Is Essa (Crawford) (2nd) against **#6 Nameofthegame (Mosqueira) (1st)** racing down the backstretch just inside the 5/8. **Crawford** "I'm sitting, he just drops over and wasn't clear, I barely escaped heels nearly went down". **Mosqueira** "It's nothing there, he's taking a hold giving away his position, I waited and went when I was clear". After video review Stewards deemed there's wasn't any impediment by the 6 who was indeed clear when dropping over. No change.

Stewards Inquiry, Trainer's and Jockey's claim of foul #5 Stormin Dave (Sanchez) (1st) against **#6 Bongino (Zenteno) (4th)** in deep stretch. **Sanchez** "My horse was lugging in tried to keep him out, and stay out of his way, the more he was clearing the more he drifted in". **Zenteno** "My horse was still running, he kept coming down and I had to take up and it cost me". After video review, #5 does come in and cause interference to #6, as a result #5 finished 1st and was placed 4th.
